3. Purchase and Sale of Digital Assets for Cash and/or Funds in the Account and/or Electronic Money

3.3. Purchase of Digital Assets using funds in the account and/or electronic money due to the specific functioning and high price volatility of digital assets on the Over-the-Counter (OTC) market, Vescon d.o.o. does not charge a percentage commission on purchases. Instead, the User submits a purchase request. Vescon d.o.o. provides an offer consisting of the quantity of digital assets and the applicable exchange rate. If the User accepts, the purchase is executed.

3.4. Sale of Digital Assets for Funds in the Account and/or Electronic Money Similarly, Vescon d.o.o. does not charge a percentage commission for sales. The User submits a sales request, and Vescon d.o.o. offers a price and exchange rate. If the User agrees, the sale is executed.

6. Digital Asset Portfolio Management

6.1. Managing the Digital Asset Portfolio According to an Agreed Strategy The fee consists of two components: - 2% annually of the total portfolio value, charged monthly. - 25% annually of the increase in the portfolio value in RSD (profit), charged every January 1st or upon withdrawal or strategy change. If the portfolio value is less than total contributions reduced by withdrawals, the profit fee is not charged.

II. COSTS

The User bears all blockchain transaction costs ("gas fees"). Users will be informed via crypto12.com about potential transaction fees based on public blockchain data. Vescon d.o.o. may charge less than the amount listed on the platform.

III. DISCOUNTS
