Terms of Service for RSS Lookup

Effective Date: July 6, 2025

1. Introduction and Acceptance Welcome to RSS Lookup (the "Service"), accessible via <https://www.rsslookup.com/> (the "Site"). These Terms of Service ("Terms") govern your access to and use of the Service provided by the operator of this Site ("we," "us," or "our").

By accessing or using the Service, you agree to be bound by these Terms and our Privacy Policy (which you should also review). If you do not agree to these Terms, do not use the Service.

2. Description of Service RSS Lookup is a free, open-source tool designed to help users find RSS feeds associated with a given URL. The Service attempts to locate RSS feed links embedded within the HTML of the submitted URL or through common feed path conventions.

3. User Conduct and Acceptable Use You agree to use the Service only for its intended purpose – finding RSS feeds. You agree not to:

- Submit URLs for illegal, harmful, infringing, defamatory, or otherwise objectionable websites.
- Use the Service in any way that could damage, disable, overburden, or impair the Service or interfere with any other party's use of the Service.
- Attempt to gain unauthorized access to the Service, its systems, or networks.

- Use any automated means (like bots, scrapers, spiders) to access or interact with the Service in a manner that places excessive load on our systems or attempts to circumvent security measures (like Cloudflare Turnstile). Moderate, good-faith use is permitted, but abusive automation is prohibited.
- Use the Service in violation of any applicable local, state, national, or international law.
