++ Neurology Combined CC exams consist of 2 or 3 of these specialties/subspecialties: Neurology, Child Neurology, CNP, EP, NDD, NMM, and VN. Any Combined CC exam that includes Neurology or one of the Neurology subspecialties listed above must be taken during the April Combination CC testing window.				
+++ \$500 late fee (\$100 for CC) required after application deadline but before late deadline. Application deadlines are 11:59 p.m. CST.				
Beginning in 2024, diplomates in Brain Injury Medicine and Pain Medicine will continue certification using the longitudinal assessment.
