3. TONE WOW reserves the right to amend, suspend, or terminate the OHWOW35 bundle plan, its pricing, benefits, or commission structure at any time, with or without prior notice, subject to applicable laws and regulatory guidelines.

##### 1. Member Benefits and Introducer Commission

###### 1.0 Member Benefits

RM35 x 3 months is preloaded by HQ and automatically subscribed to the WOW35 for 3 months

###### 1.1 Introducer Commission

###### Introducer Commission Structure

Introducer will receive reload share comms for OHWOW35 bundle plan on month 6<sup>th</sup>, 9<sup>th</sup> and 12<sup>th</sup>.

#### How to entitle:

- i. Active status: User must be in active status for their introducer to be eligible to receive commissions.
- ii. Expired status: Will result in forfeiture of related commission entitlements.

Example:

**Situation 1**

*Lim Han registered Abu on January 2025. Abu subscribed package OHWOW35 bundle plan. Abu must remain active for one year from the registration date for Lim to receive the full 'Accrued Commission' in the 6th, 9th, and 12th months*

**Situation 2**

*Lim Han registered Abu on January 2025. Abu subscribed package OHWOW35 bundle plan. Abu expired on month 5 after registrations date. As a result, Lim Han will not receive the revenue share OHWOW35 bundle plan package*

**Situation 3**

*Lim Han registered Abu on January 2025. Abu subscribed package OHWOW35 bundle plan, Abu expired on month 7 after registrations date. As a result, Lim Han receive the 'Accrued Commission' OHWOW35 bundle plan package on Month 6.*

**2. Additional Reload**

- i. Introducer will receive normal structured commissions if additional top-ups are made by their user, which means that additional reloads by the subscriber shall trigger standard commission payouts in accordance with the prevailing incentive structure.

**3. Eligibility Conditions**

- i. Subscriber must maintain active status throughout the qualifying period.
- ii. Expired status shall result in forfeiture of commission entitlements.
- iii. Commission disbursement is conditional and non-guaranteed, subject to compliance with TONE WOW's operational and regulatory policies.

### 1. Faedah Ahli dan Komisen Penaja

##### Struktur Komisen Penaja

### Syarat Kelayakan:

- i. Status Aktif: Pengguna mesti berada dalam status aktif bagi membolehkan penaja layak menerima komisen.
- ii. Status Tamat Tempoh (Expired): Akan menyebabkan hak ke atas 'Accrued Commission' tersebut terbatal.

Contoh Situasi:

#### Situasi 1:

Lim Han mendaftarkan Abu pada Januari 2025. Abu melanggan pelan bundle OHWOW35. Abu mesti kekal aktif selama setahun dari tarikh pendaftaran supaya Lim menerima 'Accrued Commission' pada bulan ke-6, ke-9, dan ke-12.

#### Situasi 2:

Abu tamat tempoh pada bulan ke-5. Akibatnya, Lim Han tidak akan menerima perkongsian 'Accrued Commission' pelan bundle OHWOW35.

#### Situasi 3:

Abu tamat tempoh pada bulan ke-7. Akibatnya, Lim Han hanya menerima 'Accrued Commission' OHWOW35 pada bulan ke-6.

### 2. Tambah Nilai Tambahan

- i. Penaja akan menerima komisen mengikut struktur insentif sedia ada jika pengguna melakukan tambah nilai tambahan. Ini bermaksud setiap tambah nilai tambahan oleh pengguna, penaja akan menerima bayaran komisen selaras dengan struktur insentif sedia ada.
