## Word Error Rate Compliance

The section shows the testing that was performed to prove ADA compliance that requires a WER (Word Error Rate) of less than 5%

### Old-English Book with British Accent

For this test completed on September 4 2025, the text from a famous book in public domain-Jane Austen's Pride and Prejudice, is compared with its audiobook. Even with our lowest accuracy AI model, this test passed successfully proving greater than 97.3% accuracy in real-time because there were only 5 words that had errors out of 186 words counted using a [word counter](#).

#### Original

Original text taken from this [free source](#): and then linted to remove quotations("’"), underscores(\_), double spaces and line breaks. Since it is old English, the grammar may still be highlighted by grammar correction tools. Here's the text compared:

The audio used for the test was played from an [audio book on YouTube](#) and transcribed with the ConferenceCaptioning v2.9.2 app run on a Macbook Pro M4 November 2024 using only the Basic (lowest) accuracy language model.
