

## **General**

This also includes the storage of data for possible warranty claims after the fulfillment of the contract.

## **Purpose of the data collection**

When you use our website, details (e.g. your IP address) are automatically registered by our web servers. When requesting personal information, we only use your personal information for the following purposes:

- For other legitimate business purposes (marketing and promotional activities; technical administration, research and development of the P-OPS Team website; analysis of user behavior and navigation within the website)

## **Contact**

When contacting or communicating with us, e.g. by e-mail or via a contact form on our website, the data you provide (your e-mail address, possibly your name and telephone number or the personal data provided within the communication) will be processed and stored by us to answer your questions or to comply with communications necessary for our business purposes. We delete the data arising in this context after the storage is no longer necessary, unless there are statutory storage requirements or limitation periods that have to be respected.

## **Protection of personal data**

The protection of your personal data is the focus of our business activities. We use appropriate technical, organizational and administrative security measures to protect information stored by us against loss, data misuse, unauthorized access, disclosure, alteration and destruction.

We do not disclose or sell your personal information to any third parties, because we care about your privacy as well as our reputation. We will retain your information only where necessary and/or required by applicable laws and regulations for the purposes in question (e.g. to protect the personal safety of the users or employees of P-OPS Team, protect the rights or intellectual property of P-OPS Team).

## **Logfiles**

When accessing our website, the type and version of the browser used are transmitted by the respective Internet browser and stored in log files on the hosting server. The IP addresses of the users are deleted or made anonymous after the end of use. In the case of anonymization, the IP addresses are changed in such a way that the individual details of personal or factual circumstances cannot be assigned to a specific or identifiable natural person or only with a disproportionate amount of time, money and effort. This usage data forms the basis for statistical, anonymous evaluations in order to improve the offer on our website and make it more user-friendly. This data is not merged with other data sources.

## **Google Analytics**

This website uses Google Analytics, a web analytics service provided by Google Inc. (Google). GoogleAnalytics uses cookies that allows us to analyze how the website is used and helps us to make corresponding optimisations related to technical, UX & marketing purposes. The information generated by the cookie about your use of this website is usually transmitted to a Google server in the USA and stored there. If IP anonymization is activated on this website, your IP address will be shortened beforehand by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. The full IP address will only be sent to a Google server in the USA and shortened there in exceptional cases.
