INTRODUCTION

Sunlight Financial LLC (“Sunlight”, “Company”, “we”, “our”, or “us”) respects your privacy. This Privacy Policy describes the type of information we collect from you when you visit the Sunlight website or use the Sunlight portal Orange[®] or the mobile application of Orange[®] (collectively, the “Services”), as either the consumer applicant for solar or home improvement financing, as a contractor working with Sunlight to provide solar or home improvement financing (“contractor” or “you”), or other Services user (“you” or “Services user”).

This policy applies to information we collect from individuals acting or working in a commercial context. Sunlight primarily offers personal, household or family financial product or services. If you are a consumer or customer of personal, household, or family financial product or service, a separate financial privacy notice will apply. This Privacy Policy is designed to inform you of the types of information we collect, how we use that information, the circumstances under which we will share it with others, and your ability to limit any sharing of your data for cross context behavioral advertising.

WHAT WE COLLECT

Sunlight collects information about you that we reasonably believe will be necessary or useful in processing or administering the products and Services you have requested. We collect the following types of information:

- information automatically collected when you visit or interact with the Services, through technology such as cookies, clear GIFs, pixel tags, log files, and other technologies including analytics and tracking tools from third-party service providers, which information often includes computer or device information, IP address, and usage information
- contractor legal entity name and information, including individual personnel contact information
- information about transactions originated through an individual contractor
- information we receive from third parties, such as from commercial credit reporting agencies, regarding contractor creditworthiness and credit history
- other information you may provide or which we collect about your business when you register as a contractor with us
- information that you provide to us, which may include when you use our Services, register or create an online account with us, request information from us, sign up for newsletters or our e-mail list, enter into sweepstakes or other promotions, fill out a survey, request customer support, or otherwise communicate or contact us, such as your name, address, e-mail address, telephone number, referrals, and information about your solar activities, such as home ownership, home statistics, home energy usage or utility provider, or demographic information

HOW WE USE YOUR INFORMATION

We use your information for the following purposes:

- when it is required to complete your transaction
- you authorize us to do so
- as permitted or required by law
- for third parties to market their products and services to you if you consent to such sharing
- to conduct business with you such as through our strategic and referral partner programs and for internal business analysis or other business purposes
- to personalize your experience with the Services, target our communications regarding products, services, or other offers, for our own internal marketing, and for internal business analysis or other business purposes

WHO WE SHARE YOUR INFORMATION WITH

We share your information with:

- our service providers
- with third parties who we or you conduct business with such as strategic and referral partners and for internal business analysis or other business purposes
- with third parties or law enforcement under legal process or as required under law\

Where this is the case, we will take reasonable measures to prevent further processing your information.

What We Sell to Third Parties or Share with Third Parties for Cross-Context Behavioral Advertising and Right to Opt-Out

We have sold or shared with third parties for cross-context behavioral advertising personal information to third parties in the preceding 12 months. The categories of personal information we may have shared with web analytics providers and third-party cookie and tracking technology providers to provide personalized ads include: Identifiers, Characteristics of CA or Federal Protected Classifications, Internet or Other Similar Network Activity, and Geolocation Data. We do not sell or share your sensitive personal information.

The purpose of the notice of Right to Opt-Out is to inform you that you have the right to direct us to stop selling or sharing your personal information, which is called the “Right to Opt-Out.”

You may exercise your Right to Opt-Out by:

- (1) Clicking “Do Not Sell or Share My Personal Data” at the bottom of our [website](#) to use the interactive form,
- (2) Submitting your request through an opt-preference signal (described further in the section titled “Opt-Out Preference Signals”)

Once you make an opt-out request, we will comply within 15 business days.

We do not have actual knowledge that we sell the personal information of minors under 16 years of age.

Your Right to Know

You have the right to request that we disclose any of the following:

- the categories of personal information we have collected about you
- the categories of sources from which the personal information is collected
- the business or commercial purpose for collecting, selling, or sharing with third parties for cross context behavioral advertising (e.g. targeted advertising)
- the categories of third parties to whom we disclose personal information
- the specific pieces of personal information we have collected about you

You can do this through a verified consumer request. That process is described below in the section, “Submitting a Verified Consumer Request.”

Your Right to Request Correction of Inaccurate Personal Information

You have the right to request correction of inaccurate personal information maintained by us. We may request documentation from you to determine the accuracy of the information. If you provide us documentation either upon our request or through your own initiative, that documentation will only be used for the purpose of correcting your personal information and complying with our recordkeeping requirements. We may deny your request if we have previously denied your same request to correct an alleged inaccuracy in the past six (6) months, unless you provide new or additional documentation that the information at issue is inaccurate.

As an alternative to correction, we may delete the inaccurate information if it does not negatively impact you or if you consent to this deletion. We reserve the right to deny this request if allowed under law, or if we determine that the contested information is more likely than not accurate, based on the totality of circumstances. You can submit a correction request through a verified consumer request. That process is described below in the section, "Submitting a Verified Consumer Request."

Your Right to Request Deletion of Your Personal Information

You have the right to request that we delete any of your personal information collected by us, subject to certain exceptions. You can do this through a verified consumer request. That process is described below in the section, "Submitting a Verified Consumer Request."

There may be scenarios where we deny your deletion request. If that occurs, we will provide you with an explanation as to why we could not delete all or some of your personal information.

How To Exercise Your Rights – Submitting a Verified Consumer Request

You have the right to submit verified consumer requests to know information, to correct information, or for deletion.

You may submit a request to know information, to correct information, or for deletion by providing your name, legal name of company you are associated with, last four digits of the EIN, and executive designated to sign legal documents on behalf of company, along with description of the type of request you are seeking, by emailing us at info@sunlightfinancial.com or by calling us toll free at (888) 850-3359. Your request will be verified by matching the information you provide to information that we have collected. For the right to know specific information, we will also require that you provide a signed declaration under penalty of perjury, which we will provide in our acknowledgment to your initial request.

The response to a request to know will provide all personal information collected and maintained about you since January 1, 2022, unless doing so proves impossible or would involve disproportionate effort. Please note that we are not required to provide personal information to you more than twice in a 12-month period. We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request.

If you submit a request that is not through one of these designated methods or is deficient in some manner unrelated to verification, we will provide you with information on how to submit the request or remedy any deficiencies.

Once we receive your verifiable consumer request, we will confirm receipt of the request within 10 business days describing our verification process. We will respond to your request within 45 calendar days, if we are able to verify your identity. Requests for deletion will require a separate confirmation that you want your information deleted.

Requests to Know or Delete for Child Under the Age of 13: We do not knowingly collect information of minors under the age of 13.

Using an Authorized Agent to Submit a Request

Only you, or a natural person or a business entity registered with the Secretary of State to conduct business in California that you have authorized to act on your behalf, may make a verifiable consumer request related to your personal information. If you use an authorized agent, you may provide a power of attorney executed pursuant to California Probate Code sections 4000 to 4465. If a power of attorney that meets those provisions is not submitted, you will be required to provide the authorized agent signed permission to submit a request, verify your identity directly with us, and directly confirm with us that you provided the authorized agent permission to submit the request.

If you're an authorized agent making a request, you must email us at info@sunlightfinancial.com and:

1. Provide the power of attorney given to you by the consumer pursuant to Probate Code sections 4000 to 4465; or
2. Provide proof of signed permission along with a copy of your ID **and** have the consumer e-mail us at info@sunlightfinancial.com to directly confirm with us that they provided you permission to submit the request.

Opt-Out Preference Signals

Our use of tracking technologies may be considered a sale/sharing under California law. You can opt-out of being tracked by these third parties by clicking the "Do Not Sell or Share My Personal Info" link at the bottom of our website and selecting your preferences, or by broadcasting an Opt-Out Preference Signal, such as the Global Privacy Control (GPC) (on the browsers and/or browser extensions that support such a signal). Your request to opt-out of sale/sharing will be linked to your browser identifier only and not linked to any account information because the connection between your browser and the account is not known to us. Because the signal is browser-specific, you will need to broadcast subsequent signals if you are accessing our website through different online devices (e.g., computers, smartphones, tablets).

Your Right to Non-Discrimination for the Exercise of a Privacy Right

We will not discriminate against you for exercising any of your CCPA rights. Unless permitted by the CCPA, we will not:

- Deny you goods or services.
- Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
- Provide you a different level or quality of goods or services.
- Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.

Changes to Our Privacy Notice
