Dear Comptroller:

We wish to report a serious criminal activity by the World Bank and its affiliates, including the Central Bank of the Philippines, seeking to defraud the Donors and Beneficiaries of private trust assets via the unlawful and non-consensual conversion of American Common Law Trusts into Statutory Trusts.

We have public admission by one of the Perpetrators, a man claiming to be Tiburcio Villamor Marcos, who is in fact an actor named Alec Tallon, to the effect that the Perpetrators entered into a fifty-year long secret agreement for the purpose of liquidating the substituted statutory trusts --trusts which would otherwise exist in perpetuity as American Common Law Trusts-- thereby defrauding and disinherit the Donors and the Donors' Beneficiaries via unlawful conversion and deliberate secretive liquidation of the substitute statutory trusts.

We have further been informed that the Code FLAT Trust Accounts numbered 111, 333, 555, 777, and 999 have been non-consensually mirrored to create corresponding Cash Accounts numbered 222, 444, 666, and 888 --- which the Perpetrators of these schemes have used to promote their crimes and provide payola to their Accomplices.

All cash assets based on our gold, silver, land, and other physical assets including all credit notes are ours and are property of our lawful Government and our people, including the Donor-Inheritors of these trusts and assets who maintain the right to administer them according to their respective Trust Indentures without respect to any claims of custodial interest by any foreign and merely statutory government.

Nobody deriving from or living on the Philippine Islands has any standing to claim ownership of any physical asset. The Philippine Islands are owned by The United States of America, our unincorporated Federation of States. As we received the land assets in settlement of Spanish-American War via the Treaty of Paris in 1898, and as our money was used to pay an additional \$20 Million dollars in support of the Philippine Government at that time and there has been no further land jurisdiction treaty or payment to us, we still own the land and soil of the Philippine Islands.

This results in a situation in which no Filipino, including Ferdinand E. Marcos, has had standing to claim any physical assets stored in the Philippines then or now. This prohibition also extends to all Code FLAT and Saint Germain Trust Funds assets deployed worldwide.

Even if Alex Tallon really were Tiburcio Villamor Marcos, and even if the so-called Secret Fifty-Year Agreement was anything but a self-admitted Breach of Trust Fraud Scheme, the provenance of all claims derived from Ferdinand E. Marcos and his numerous relatives lack standing to mirror cash accounts based on our assets or encumber the private trust fund assets of others to create the so-called 666 Account; the failure of the Central Bank of the Philippines and the World Bank to notify the Trust Donors in no way justifies their suppositions and attempted unlawful conversion of the assets.

The Supreme Court of the Philippines has already recognized the lawful Heir and Donor and Inheritor of the Code FLAT Accounts, so there is no excuse for this run around. The lawful Heir and Donor and Inheritor is an American who has adopted South Carolina as his permanent house, home, and domicile, and he has placed his assets in all jurisdictions under the Public Law of our Government and affirmed the original trust indenture as a private American Common Law Trust, not a Statutory Trust.

The Vatican Chancery Court has already admitted the standing and provenance of the known Saint Germain Trust Donor-Heirs.

There is, therefore, a great deal of fraud taking place on a worldwide basis, as guilty banks and guilty self-proclaimed trustees acting as Executors de Son Tort attempt to claim that the substitute statutory trusts have lapsed and that no beneficiaries or donors remain; this cannot be maintained in the face of the findings of the Vatican Chancery Court, the Supreme Court of the Philippines, and Federal District Court findings and orders, nor can these actions by the Perpetrators be condoned in the face of these and other correspondences fully informing your Office, the Secretary of the Treasury, and numerous other responsible parties that this fraud has been deliberately implemented by known actors.

All assets deposited by Severino Sta Romana, all funds deposited by Giovanni Baptista (sometimes spelled Babbista) Richello and their personas, all assets of the similarly deployed Saint Germain Trust, **along with all cash asset accounts derived from these assets** are to be returned to The United States of America and to the control of the actual recognized Heirs and Donors --- not the would-be executors of our estates.

The actual recognized Heirs and Donors of the Code FLAT and Saint Germain Trusts hereby fully inform you and all others in receipt of this correspondence that we immediately extend the substitute statutory trusts for another fifty years pending their removal to the original and intended jurisdiction of the land and soil of this country and their proper administration under their original trust indentures.

The Government of the Philippines is also fully informed of the limitations of their jurisdiction and the actual ownership interest of The United States of America. The Government of the Philippines is, in effect, in possession of stolen goods and authorities that were extended to them by a Scottish Commercial Corporation formed in 1868 impersonating us and pretending to represent us – while in fact acting as pirates in possession of assets belonging to us.

By Maxim of International Law, "Possession by pirates does not change ownership."

The Government of the Philippines is responsible as the Trustee these Pirates left in charge after their own corporate bankruptcy, for returning our purloined assets; failing that, they must be recognized as pirates in possession themselves.

As Comptroller of the Currency we expect you to realize that no "state of war" of any kind pertaining to this country exists as of 1 August 2021 and all World War and related conflicts are scheduled to be officially and peacefully ended as of 25 June 2022. Any actions predicated on False Legal Presumptions of Enemy Combatant status or fictitious battlefields and military occupations are to be pre-emptively stopped and all the accounts properly credited and administered from now on.

Theft of capital assets belonging to our Government and People by our contractors and employees, even if brokered by foreign governments and institutions, is Treason.

Notice to Agents is Notice to Principals; Notice to Principals is Notice to Agents.
