Grant of Non-Exclusive Worldwide Rights

In consideration of the purpose and goals of the Society and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, you hereby grant to the Society, its employees, agents, licensees and members who are acting on its behalf, the non-exclusive, royalty-free, perpetual, non-revocable, worldwide, right to use, publish, distribute, modify and copy the Works (as defined below) (including the right to sublicense to third parties), in any media now or hereafter known, in any SABR publications, online digital publishing programs or in connection with any other projects of SABR and its affiliates. "Works" means any works of authorship (written or otherwise), presentations, contributions, materials, information, displays, videos, audio or other items that you may provide or present at any SABR conferences or other events or otherwise make available to SABR, including those provided prior to the date hereof or thereafter. You also waive any right to inspect or approve the finished product and any right to royalties arising from the use of the Works by SABR or its sublicensees.
