This Privacy Policy explains how we collect, use, and safeguard your data across our website, membership systems, events, and digital communications.

Information We Collect

We may collect the following types of information to enhance your experience and provide TAHPERD member services:

Information You Provide:

- Name, contact information, and membership details when you join, renew, or register for an event.
- Optional profile details, such as professional role, organization, or areas of interest.
- Communication records, such as emails, support requests, and survey responses.

Automatically Collected Information:

- Website usage data, including pages visited, time spent, and referring links.
- Device and browser information, including IP address and operating system.
- Aggregated analytics used to improve content, navigation, and user experience.

TAHPERD does not collect sensitive information such as payment card details (processed securely through third-party vendors), precise location data, or personal health information.

How We Use Your Information

We use your information to:

- Provide access to member benefits, resources, and event registrations.
- Communicate important updates, newsletters, and professional opportunities.
- Improve TAHPERD programs, services, and digital platforms.
- Respond to inquiries and provide support.
- Comply with applicable laws and association policies.

Information Sharing and Disclosure

TAHPERD does not sell or rent your personal information.

We may share limited data with:

- Service Providers: Trusted vendors assisting with operations (e.g., website hosting, email delivery, data management).

- Legal Compliance: When required by law, regulation, or valid legal process.

All third-party partners must adhere to data protection and confidentiality standards consistent with this policy.

Data Security

TAHPERD implements administrative, technical, and physical safeguards to protect your personal information from unauthorized access, disclosure, or misuse. While we strive to protect all information, no system is completely secure, and users share data at their own discretion.

Data Retention

We retain member and participant information only as long as necessary to fulfill association purposes, meet legal obligations, or maintain historical records of TAHPERD membership and participation.
